About the 1st National Legal Hackathon: Legal Start-up & Business Plan Competition 2022-23

Legal field has been facing various challenges for the last few decades especially in terms of pendency of cases and complex legal compliance. To address these situations, we need to come up with innovative mechanisms, initiatives in the said field. Innovation and Startups in the legal field are the answer to this. We can witness many startups have come up in the legal field in the last few years especially by young minds. Ministries, Government Departments /bodies have initiated various innovative schemes for serving people at large.

The Management Studies Committee, School of Law, Christ (Deemed to be University), in collaboration with C-IESC, is launching its 1st National Legal Hackathon: Legal Start-up & Business Plan Competition 2022-23, open to under-graduate, post-graduate students and research scholars who are presently enrolled with any University and College across the country with the aim of stimulating the spirit of entrepreneurship among students. The primary purpose of this competition is to provide an opportunity for budding entrepreneurs across the country to present their ideas and to create a platform for all legal start-ups to exhibit their ideas and work in a competitive ambience.

The Theme of the Competition

The theme of the event is “**Automation and Empowering Justice**”. Empowering justice is an approach that enables communities facing injustice to use legal mechanisms to pursue transformative improvements to current laws and systems. The main goal of the competition is to showcase the legal start-ups, exhibit their functioning, the challenges they faced or are facing, and the outcome achieved by them.

The main objective of conducting such an event is to provide individuals with a platform to present their business ideas for establishing a legal start-up with the intent to motivate and provide practical and technical guidance for improvement. It aims to help individuals hone their skills to give them an early boost in their law school lives and their professional careers.

Objectives

- To support legal start-ups.
- To determine their own legal career prospects and to inspire students.
- To offer all assistance necessary for establishing legitimate start-ups



Guidelines of the Competition

The competition is open to all undergraduate, postgraduate, PHD scholars. The competition will be conducted in three phases: the first phase will be a **screening round**. The second will be the **preliminary round** which will be held virtually on Webex. And the **final round** will be conducted offline at the School of law, Christ (Deemed to be University), Bengaluru.

Screening Round (Round 1)

Teams will be evaluated and shortlisted based on the proposal submitted by them.

The Proposal Document shall include:

- Introduction
- Problem
- Solution

The teams are required to send their initial proposal for the screening round in not more than 350 words. The submissions should be done in PDF format.



Guidelines of the Competition

Preliminary Round (Round 2)

The preliminary round will be conducted online on the Webex platform.

The selected teams will be will have to submit another document for the second round in accordance to the following guidelines (marked as Annexure 1).

NOTE: The document should not exceed 6 pages.

The teams would be given 8 minutes to present their Idea in brief which will be followed by a Q&A Session which would last for 3-5 minutes.

Guidelines of the Competition

Final Round (Round 3)

The teams will be given 15 mins to present their ideas, followed by a 6-8 mins Q&A session.

The final business plan should consist of:

1. Introduction page which should include:
 - Names of all the members, affiliation, Mobile no. Email Id
 - Table of Contents
 - Executive Summary
2. Details as per Annexure II.

NOTE: The document shall not exceed 15 pages. (Additional 05 pages can be attached as supporting documents)

Business Idea/ Proposal for the final round should be sent in PDF file along with a business presentation in PPT/PDF format.

ANNEXURE 2

1. Introduction & Team

Brief Introduction and team members' information.

2. Business

Business idea in detail. Mention the objective behind the idea or the Initiative undertaken, details of the plans put forth for the fulfillment of the objective, and in detail mention of the objectives of the initiative.

3. Problem

Mention the background behind the idea. Identify and highlight the problem the business has been trying to address.

4. Solution

What is the solution or business model? Mention the solution proposed and highlight the extent to which a solution can be achieved.

5. Market

How big is the market? Expectant population that can benefit from the initiative.

ANNEXURE 2

6. Market Analysis

- Strengths, Weakness, Opportunity, Threats
- PESTEL analysis – Political, Economic, Social, Technological, Environmental and Legal

7. Competition

How do you plan to compete against existing solutions?

Execution Plan – How execution is being done? (In Stages)

8. Legal compliances & IP protection

What laws are complied with for setting up and registering the startup?

What IP protection is given for the logo/name/services provided?

9. Financials

What is present and projected financial performance?

- Sources of Funds
- Revenue Model
- Allocation of funds

10. Milestones

What are the proposed milestones the business must achieve in the legal field?
